At Commissioner Yoder's request, Christa Miller explained the Voters will be able to see the proposed polling changes on the county website.

Update on the May 20, 2025, Primary Election

Christa Miller, Chief Clerk/Chief Registrar

Christa Miller reported that there are 357,897 registered voters in Lancaster County, with 294,433 eligible to vote in the Primary Election. She noted that this figure includes Colerain Township, which has an additional item on the ballot that permits all parties to vote on it. There have been 22,643 mail-in ballot requests so far, with ballots scheduled to be mailed out in the middle of next week. Poll worker training will begin next week, and logic and accuracy testing has started and will continue into the following week. Christa stated that everything is on track and that her team is caught up on all preparations.

Commissioner D'Agostino and Jacquelyn Pfursich responded to Commissioner Parsons questions about date setting in response to a court ruling.

Commissioner D'Agostino noted that the next meeting will take place on April 23, 2025.

On motion of Commissioner Parsons, seconded by Commissioner Yoder, the meeting adjourned at 9:17 a.m.
